## Janus Decision Not Favorable For Teachers' Unions

On Wednesday June 25th, the long awaited Supreme Court decision in the Janus Case came through, and it was not the decision teachers' unions across the US were hoping for. The 5-4 decision overturned the over four-decade long precedent allowing the mandated collection (in 22 states) of agency fees for teachers' unions, as well as non-education related unions.

Some labor experts fear that this decision could have unions facing the possible consequence of losing up to a third of paying members nation wide. This is a threat to teachers' unions as it will weaken their power locally, nationally, and politically.

How this affects VSTA will remain to be seen, but it is our sincere hope that our members unite and stay strong, together.




## A Message from the VSTA Officers
